**Entry information:** Pre-entry fee for this event is \$35; post entry (>5/13/2013) fee = \$45. Women/Youth \$25 (no late fee)

**Pre-Entry Cutoff:** May 13, 2013

**Row Assignments:** Row requests will be honored on the basis of the earliest postmark. In the event the row request is unavailable, the nearest row will be assigned. Maximum 4 riders per row. Please staple your entry forms together if you wish to ride together.

**Sign up:** Saturday, May 18 from 2 to 6 PM and Sunday May 19 at 6 AM. Riders meeting 7:15 AM Sunday.

**Course:** Approximately 60 miles for long course riders. Ground miles for short course is 45-48 miles and 20 miles for extra short course.

**Scoring:** Traditional score cards will be used to record your start and check out test section results including minutes and seconds. Please tape your scorecard to your front fender with the top of the card closest to the fork tubes.

**Fuel:** All gas stops are located near the Start/Finish line.

**Sound test:** Motorcycles are required to meet 96db @ 20 inches. BJEC cards accepted. Headlight and license plate not required to ride this meet.
