- **Row Assignments:** Row requests will be honored on the basis of the earliest postmark. In the event the requested row is not available, the nearest row will be assigned. Max 5 riders per row. Please staple your entry form together for same row assignment. NO CHANGES Day of the Event.
- **YOU MUST HAVE AN AMA CARD TO RIDE THIS EVENT THAT IS CURRENT THROUGH MAY 2010.** You can join AMA for \$39.00 at signup.
- **Scoring:** All scoring will be done electronically, transponders will be available for \$30.00 and can be returned for a \$20.00 rebate.
- **Fuel:** Two gas stops for long course riders; bring two cans. You must be able to ride 33 miles between gas stops.
- **Signup:** Saturday May 15 from 2:00-6:00 PM. Sunday 6:30-8:45 AM.
- **Sound test/inspection:** Motorcycles are required to meet 96 db @ 20 inches; BJEC cards accepted. Headlight and license are not required.
- Approximately 65 miles for long course riders. Ground miles for short course is 45-48 miles and 20 miles for extra short course riders.
